ELIGIBILITY

The technical exhibit area is open to exhibitors whose products or services are both scientific and/or commercial and must be for use in or related the science of Pharmacometrics/clinical pharmacology. All new exhibiting companies applying to exhibit at the 2020 Conference are subject to ISoP Board of Directors approval.

CANCELLATION POLICY

All requests for cancellation of space must be received in writing.
