

## **ACoP11 Discount/Waiver Application**

The mission of the International Society of Pharmacometrics (ISoP) is to promote and advance the discipline of Pharmacometrics and broaden its impact. As part of that vision, ISoP would like to make this year's virtual ACoP11 accessible to attendees around the world. With this in mind, individuals residing and training /practicing in the field of pharmacometrics in low- and middle-income countries (LMIC)## are invited to apply for a discount or waiver of ACoP11 registration fees:

• This waiver applies to any individual who resides and is training/practicing\* in the field of pharmacometrics in LMIC.

\*Non-trainees must be employed by an organization that is located wholly within a low- and middle-income country. *Applicants will not be eligible if:* 

- An applicant who resides in LMIC but is employed by an organization that is located in a high-income country is not eligible for this discount.
- An applicant who previously resided in LMIC but now practices in a highincome country is not eligible for this discount.
- An application that resides and practices in LMIC and is self-employed but contracts to organizations from a high-income country are not eligible for this discount.
